

POLICY ON ADMISSION TO MARTON PRE-SCHOOL

For admissions between September 2018 and April 2019

The Governors of Marton-cum-Grafton CE (VA) Primary School offer high quality Early Years provision in a 13 place Pre-school catering for children aged 3 to 5 during Marton-cum-Grafton Primary School's term time only. This policy sets out how places are allocated for the Pre-school and the procedures for applying for a place.

A place in the Pre-school does not have any bearing on whether the child will get a Reception place at Marton-cum-Grafton Primary School. Parents **MUST** also fill out an Admissions form for both Marton-cum-Grafton Primary School and North Yorkshire County Council separately for a Reception place.

The Early Years Entitlement

Early Years Entitlement enables all children to access early learning and care based provision from the term after their third birthday. The entitlement is for up to 15 hours a week over a minimum of 38 weeks of the year. Parents who meet the relevant criteria can access a further 15 extended entitlement hours a week and further information about this can be found on the North Yorkshire County Council website at <http://www.northyorks.gov.uk/article/33505/30-hours-extended-early-years-entitlement-for-eligible-three-and-four-year-olds>

This means that:

- Children with birthdays between 1st January and 31st March can access pre-school provision from the start of the following Summer term (after Easter).
- Children with birthdays between 1st April and 31st August can access pre-school provision from the start of the following Autumn term (September).
- Children with birthdays between 1st September and 31st December can access pre-school provision from the start of the following Spring term (January).

Parents are able to request any combination of Pre-school sessions, subject to availability. Part sessions are not allowed. Parents may apply for further full sessions above their 15/30 hours entitlement and will be charged according to our terms and conditions document.

Session times are as follows:

Mornings	9.00 a.m. to 12.00 p.m.
Afternoons	1.00 p.m. to 3.10 p.m.
Lunch time	12.00-1.00pm
All day –	9.00 a.m. to 3.10 p.m. (6 hours)

Applying for a place at or to change hours in Marton Pre-school.

The closing date for applications or change of hours is as follows:

- By the 31st May for a September start.
- By the 31st October for a January start.
- By the 31st January for an April start.

Parents **MUST** complete a Pre-school Application Form (or change of hours form if the child is already in Pre-school) available from Marton-cum-Grafton Primary School's office or Marton-2018-19 Pre-school Admissions

cum-Grafton Primary School's website at www.marton-cum-grafton.n-yorks.sch.uk for the term they wish their child to start and return it to Marton-cum-Grafton Primary School's office either by post (Reas Lane, Marton-cum-Grafton, York, YO51 9QB) or email (admin@marton-cum-grafton.n-yorks.sch.uk) by the relevant closing date above. A Supplementary Information form should also be returned with the Application Form if the child falls into criteria 5-13 of the Oversubscription Criteria listed below.

Allocating places

The Published Admission Number of our Pre-school is 13. This means that there are 13 places available in each session. Following the closing date, the admissions panel will meet and will rank all applications according to the Pre-school's Admissions Criteria listed below and not according to when the application was made.

The offer of sessions will be made according to the over-subscription criteria and availability of sessions and will endeavour to meet parental requests wherever possible.

On behalf of the governors a member of Marton-cum-Grafton Primary School's office staff will contact all applicants approximately half a term in advance of the start date informing them of the offer. If the place is not accepted it will be re-allocated according to the ranking list.

If the Pre-school is over-subscribed, parents who have been unsuccessful can request that their application is placed on a waiting list. These applications will be processed following the next closing date for admissions.

Late Applications

If an application is received when a child is already over 3 years old, sessions will be offered if these are available and the child will be able to start at the beginning of the next school term. If the Pre-school is full, the application will be placed on the waiting list.

Criteria for Admission into the Pre-School

Governors use the following criteria when prioritising applications. Where we receive more applications than the number of places available - the Published Admission Number, currently 13 - the governing body will prioritise applications using the following criteria:

Admissions Criteria

Over-subscription Criteria

Children with a statement of special educational need and/or Education Health and Care Plan which names the Pre-school will be admitted. (In accordance with section 324 of the Education Act 1996 and Children and Families Act 2014)

Where there are fewer applications than places available, all children will be admitted.

In the event that more applications are received than there are places available, places will be allocated in the following order of priority:

1. Looked after children or previously looked after children for whom Marton Pre-school has been expressed as a preference, including children who have been adopted but who were previously in public care; those with a child arrangement order; and those with special guardianship.
2. Children who have their fourth birthday during the academic year that they wish to be admitted to the Pre-school (1st September to 31st August).

3. Children who have a sibling¹ at Marton Pre-school and/or Marton-cum-Grafton CE VA Primary School (Reception to Year 6) at the closing date for the relevant Pre-school application round.
4. Children living in the ecclesiastical parish of Christ Church, Marton-cum-Grafton. A map showing the parish boundaries can be inspected at Marton-cum-Grafton Primary School.
5. Children 'at the heart of the Church', who live in the parishes of Great and Little Ouseburn with Marton-cum-Grafton and Whixley with Green Hammerton, Arkendale, Dunsforth and Aldborough. This category applies if the child and at least one parent, guardian, or carer ordinarily attends a Christian Church² not less than twice a month in the two year period immediately preceding the closing date for the relevant Pre-school application round.
6. Children 'attached to the Church', who live in the parishes of Great and Little Ouseburn with Marton-cum-Grafton and Whixley with Green Hammerton, Arkendale, Dunsforth and Aldborough. This category applies if the child and at least one parent, guardian, or carer ordinarily attends a Christian Church² once a month for church services, or if the child is regularly involved in a weekday church activity including an element of worship, in the two year period immediately preceding the closing date for the relevant Pre-school application round.
7. Children 'known to the Church', who live in the parishes of Great and Little Ouseburn with Marton-cum-Grafton and Whixley with Green Hammerton, Arkendale, Dunsforth and Aldborough. This category applies if the child and at least one parent, guardian, or carer occasionally attends a Christian Church² for religious worship not less than twice a year in the two year period immediately preceding the closing date for the relevant Pre-school application round. This might include, for example, Christmas, Easter or Harvest services but not, for example, attendance at weddings, funerals, or ceremonies at which attendance was by invitation.
8. Children who live outside the parishes of Great and Little Ouseburn with Marton-cum-Grafton and Whixley with Green Hammerton, Arkendale, Dunsforth and Aldborough, but within a radius of 3 miles of the Pre-school and who are 'at the heart of the Church'.
9. Children who live outside the parishes of Great and Little Ouseburn with Marton-cum-Grafton and Whixley with Green Hammerton, Arkendale, Dunsforth and Aldborough, but within a radius of 3 miles of the Pre-school and who are 'attached to the Church'.
10. Children who live outside the parishes of Great and Little Ouseburn with Marton-cum-Grafton and Whixley with Green Hammerton, Arkendale, Dunsforth and Aldborough, but within a radius of 3 miles of the Pre-school and who are 'known to the Church'.
11. Children who live outside the parishes of Great and Little Ouseburn with Marton-cum-Grafton and Whixley with Green Hammerton, Arkendale, Dunsforth and Aldborough, but within a radius of 3 miles of the Pre-school and who attend a place of worship of another major world faith other than Christianity as represented in Great Britain (ie Buddhism, Hinduism, Islam, Judaism, Sikhism) who but for being of another faith would otherwise come within the category 'at the heart of the Church'.
12. Children who live outside the parishes of Great and Little Ouseburn with Marton-cum-Grafton and Whixley with Green Hammerton, Arkendale, Dunsforth and Aldborough, but within a radius of 3 miles of the Pre-school and who attend a place of worship of another major world faith other than Christianity as represented in Great Britain (ie Buddhism, Hinduism, Islam, Judaism, Sikhism) who but for being of another faith would otherwise come within the category 'attached to the Church'.

13. Children who live outside the parishes of Great and Little Ouseburn with Marton-cum-Grafton and Whixley with Green Hammerton, Arkendale, Dunsforth and Aldborough, but within a radius of 3 miles of the Pre-school and who attend a place of worship of another major world faith other than Christianity as represented in Great Britain (ie Buddhism, Hinduism, Islam, Judaism, Sikhism) who but for being of another faith would otherwise come within the category 'known to the Church'.
14. Children living within a 3 mile radius of the Pre-school.
15. All other children.

Tie Breaker – If there are more applications falling within any of the above criteria than there are places remaining, available priority will be given firstly to children who have a sibling¹ at Marton Pre-school and/or Marton-cum-Grafton CE VA Primary School (Reception to Year 6) at the closing date for the relevant Pre-school application round, and then to those children living nearest to Marton Pre-school³ (see below). In the event that two (or more) pupils live in the same building (e.g. flats) or otherwise equidistant from the Pre-school, then any final place(s) will be allocated by the drawing of lots.

Parents of children whose situation falls under sections 5-13 of the Over-subscription Criteria are asked to complete the supplementary information form obtainable from Marton-cum-Grafton Primary School's office or from Marton-cum-Grafton Primary School's website at www.marton-cum-grafton.n-yorks.sch.uk and should submit this with their application form. A map is available showing Christchurch's boundaries if required. The form needs to be signed by a priest/minister/vicar and confirmation given that the parent(s) and child worship regularly at their church.

Definitions and Interpretations

1. Siblings are defined as brothers, sisters, step-brothers, step-sisters, "children of the family", or long term foster children.
2. Christian Church is a place of worship which is affiliated to Churches Together in Britain and Ireland or one which is in full sympathy with the Trinitarian Creed.
3. Proximity to the Pre-school will be measured by the shortest walking distance from home to the main entrance of Marton-cum-Grafton Primary School as electronically measured by the Local Authority.

Supplementary Application Form for a place at Marton Pre-school

This form **must** be completed by your minister/priest/faith leader and returned directly to Marton-cum-Grafton Primary School's office. Responsibility remains with parents to ensure that this form is returned to Marton-cum-Grafton Primary School's office. Failure to have this form endorsed and signed by the relevant minister of religion will mean that the application will be treated as if the child has no connection with any faith.
